This position serves as the subject matter expert as it relates to Georgia State and Financing Investment Commission (GSFIC) contracts and has direct involvement in the competitive selection processes for construction. The Contracts Administrator also performs other job-related duties as assigned.

<u>Minimum Qualifications</u>: An undergraduate degree from an accredited college or university <u>AND</u> two (2) years of practical experience with purchasing and contracting for a public or private sector entity; <u>OR</u> Relevant experience with construction industry procurement/contracting.
