Call to order and approval of June 9, 2021 meeting minutes.

The minutes of the previous Commission meeting held on June 9, 2021 were approved without reading; the minutes had been previously distributed to all members prior to the current meeting. State Auditor Greg Griffin made a motion to approve the minutes and State Treasurer Steve McCoy seconded the motion. A vote was taken, and the motion passed unanimously.

Georgia Housing and Finance Authority: Request for the approval of the issuance and sale of up to \$250 million in aggregate principal of single-family mortgage revenue bonds during calendar year 2022.

A motion was made by State Auditor Greg Griffin to approve the request, seconded by Lt. Governor Geoff Duncan. A vote was taken, and the motion was passed unanimously.

State Properties Commission: Request for the approval of up to \$125 million in contract value authority for multiyear lease rental agreements during fiscal year 2023.

A motion was made by State Auditor Greg Griffin to approve the request, seconded by State Treasurer Steve McCoy and passed unanimously by all members present.

Request for the approval of the redirection of bond proceeds on behalf of:

- Department of Behavioral Health and Developmental Disabilities
- Georgia World Congress Center Authority

For each of the redirection requests, a motion was made by State Treasurer Steve McCoy to approve the request, seconded by State Auditor Greg Griffin, and passed unanimously by all members present.

Information item: Presentation to the Commission of redirection transactions that are less than \$250,000 (since June 9, 2021).
