Structural Engineer (Design Review)

Position Overview

Position Description: Under general supervision of a Senior Structural Engineer, the Structural Engineer evaluates and reviews designs, drawings, and specifications for new buildings/structures and for renovation projects. Serves a point of contact for construction projects for applicable state building codes, local and federal laws. This position also performs other job-related duties as assigned.

Minimum Qualifications:

- Completion of an undergraduate degree in the discipline Civil Engineering with a Structural emphasis from an accredited college or university **AND** four (4) years of experience in structural design, construction document preparation and review, building/fire codes analysis and implementation and/or construction administration
- Must have an active Structural Engineer License as a Structural Engineer in the State of Georgia; **OR**, if Professional Engineer License in Structural Engineering is currently active in another state, it must be active in the State of Georgia within one (1) if date of hire.
- Must have valid driver's license and the ability to travel statewide.

Preferred Qualifications: Preference will be given to applicants who, in addition to meeting the minimum qualifications, possess the following:

- Plan review experience for a local municipality or state government.
- Master's Degree in Structural Engineering
- Experience coordinating professional engineering staff
