<u>Senior Mechanical Engineer:</u> Under broad supervision, evaluates and reviews designs, drawings and specifications for new buildings, other structures and renovation projects. Serves as a point of contact for construction projects for applicable state building codes, local and federal laws. This position also performs other related duties as assigned.

Mechanical Engineer: Completion of an undergraduate degree in the Mechanical Engineering discipline from an accredited college or university AND four (4) years of experience in mechanical design, construction document preparation and review, building/fire codes analysis and implementation, and/or construction administration. Must have an active Professional Engineer (PE) License as a Mechanical Engineer in the State of Georgia, OR, if PE License in Mechanical Engineering is currently active in another state, it must be active in the State of Georgia within one (1) year of date of hire. Must have a valid driver's license and the ability to travel statewide.

<u>Senior Mechanical Engineer</u> Completion of an undergraduate degree in the Mechanical Engineering discipline from an accredited college or university AND eight (8) years of experience in mechanical design, construction document preparation and review, building/fire codes analysis and implementation, and/or construction administration. Must have an active Professional Engineer (PE) License as a Mechanical Engineer in the State of Georgia, <u>OR</u>, if PE License in Mechanical Engineering is currently active in another state, it must be active in the State of Georgia within one (1) year of date of hire. Must have a valid driver's license and the ability to travel statewide.
